01 – Categories of Personal Data We Collect

Through your use of the App we may collect:

- Email address
- Behavioral usage data (e.g., features accessed, time spent)
- Device identifiers (e.g., IDFA, IDFV for iOS; GAID for Android)
- Network information (e.g., MAC address, network operator)
- Device details (type, brand, model, OS version, language)

02 – How We Use Your Personal Data

We process your personal data to:

- Create and maintain a secure and trusted environment, including protecting the security of the App, networks, and systems
- Provide, administer, analyze, develop, improve, and optimize the App and its performance
- Perform our contract with you and deliver the Services
- Communicate with you and respond to your requests or inquiries
- Market the Services to current and prospective users
- Comply with applicable laws, regulations, and legitimate business needs
- Understand your needs and offer more personalized services

03 – Disclosure of Personal Data

We may share your personal data with:

- Our employees who require the information to operate the App and provide the Services
- Suppliers, service providers, and other third parties with whom we have a commercial relationship for business-related purposes
- Any organization for an authorized purpose when you give us express consent
- Law-enforcement bodies, courts, or regulators when required to comply with legal obligations or to protect our rights, property, and safety

04 – Security of Personal Data

We have implemented appropriate physical, electronic, and managerial safeguards to protect personal data against unauthorized or accidental access, use, alteration, disclosure, or destruction.

05 – Retention of Personal Data

We retain personal data only for as long as necessary to fulfill the purposes for which it was collected (or any directly related purposes), subject to any longer retention required by law or regulation.

06 – Your Privacy Rights

You may:

- Request access to the personal data we hold about you
- Request correction of inaccurate or incomplete data
- Request erasure of your data in certain circumstances
- Restrict processing of your data where applicable
- Withdraw any consent you have previously provided
